# Chief's Report:

Calls: 17 total calls, 3 Fire Calls, 11 EMS and 3 calls for service.

**Staffing and Recruiting:** CVA 19-01 has completed their second weekend at Station 21. They have been working on ladders and have now moved onto hoses and supply. We continue to receive inquiries for opportunities to become a volunteer, we have 5 individuals that would like to participate in the Buckley winter academy. We have FF Cruz in EMT School and FF/EMT Jividan has started his academy with Redmond Fire & Rescue.

**Training:** Captain Szarko and I went to Buckley to get trained on the new regional fit test machine for our SCBA's. This was purchased on a grant to provide all Pierce County Fire Districts the ability to perform this annual test with new equipment and standards. I have completed the ICS400 class and am trying to schedule my HR class which will be in Tacoma on the 9<sup>th</sup> of October. The department has been working on vehicle fires/extrication. On the EMS side, Behavioral Emergencies and Overdose.

**SS911:** FF Watkins is scheduled for a second Public Information & Outreach Roundtable next month. He and I will be taking part in a webinar on the September 12<sup>th</sup> that will outline how SouthSound911 and the participating Fire/Police departments will integrate PulsePoint into the dispatch system and who will be alerted when there is a CPR in progress.

**Fleet Status:** Last week E77 developed a problem with the transmission not down shifting and the Jake brake is non-operational also. We have taken E77 to West Pierce for diagnosis of the problem, I'm hoping that something got disconnected or a sensor quit working. C77 is going to need a set of tires before the rain really sets in, we can see the wear-bars on the tires.

Good of the Order: We have had Mark Shinkle from Cascade Fire & Safety representing KME fire engines bring us 2 different engines for us to look at. He wants us to buy a Cadillac and I told him a Chevrolet would do us just fine. The last engine he brought would not make the turn from upper Hyada to North East Side Drive. I don't think he would have believed it if he didn't see the turning considerations we need to keep in mind with our new engine. I will be out of town for a couple of days to celebrate Lisa's and my 35<sup>th</sup> wedding anniversary. Captain Szarko will be out of town at the end of the month for his anniversary and Battalion Chief Rapozo will be gone for 2 weeks with his Mother for the anniversary of his Father's passing last year. Going into October we are hosting a 3-day class on strategy and tactics and we have a meeting with the community on senior safety, falls in the home and stroke at St. Mathew's Church.

# **OLD BUSINESS:**

- 1. Town Center Development Status: Chief Wassall also attended the Pierce County Planning and Land Use meeting and noted that Pierce County pointed the developers to the Browns Point Community Plan long range guidelines and regulations not just Pierce County regulations. Cliff McCollum noted that the developers will present utility plans the 1<sup>st</sup> of the year. The County pointed out that there is no wiggle room on the height limitation.
- 2. EMS Lid Lift: The For committee headed by Dick Collins, who has citizen endorsements, will send out a letter once funded. No against committee currently. The department can send out one factual mailer. Commissioner Noll shared a 4-page draft example created from another fire department. Our mailer should be ready by Oct. 7th (printed, folded and ready for mailing). Cliff McCollum suggested the information be shared on social media ahead of our mailer. The Fire Department has limits regarding elections. The Pierce County Fire District 13 Firefighter Association has more freedom. We need to take into consideration our website vs. social media like Facebook. Commissioner Noll will provide labels for mailing our factual document.
- 3. 2020 Budget Cycle: Reviewed. Commissioner Noll suggested one budget without lid lift passage, and one with.

## **NEW BUSINESS:**

- Chief Review-October: Commissioner <u>Noll</u> noted that Chief Wassall's review is due the end of October. Commissioner Noll requested a copy of the job description and Commissioner Zuluaga will share the format used for prior Chief McCollum.
- 2. EMS & Mental Health Patients: New protocols are being reviewed by the EMS council regarding transport of mental health patients to the hospital (police or fire). Mental health interfaces with law enforcement. Safety for all with mental health patients is the major focus. Cliff McCollum noted that our OTEP training tonight will be on mental health protocols.

**Public Comments:** Cliff McCollum noted that copper theft has increased in the City of Tacoma. Tacoma City Light is asking for help from the community in recognizing the theft as they don't work at night. NE Tacoma copper wire was stripped in about a 4-week period.
