SPECIAL REPORTS AND /OR STANDING COMMITTEES:

Chief's Report:

Calls: 11 total calls, 0 Fire Calls, 8 EMS, 3 Service Calls.

Staffing and Recruiting: CVA 2020-01 has begun and out of 20 recruits we have 5. We also currently have 4 in EMT school at Ashford/Elbe. 1 of the 4 has already gone through fire academy and the other 3 will most likely be going to fire academy in August. The August group is all but set, we currently have 8 that would like to go.

Training: Our MSO has been updating the training calendar, we have brought on new EMT's, we are immersing them quickly to be able to know and work with the remaining fire fighters in a support roll. The Training Captain's position has been tested and I am finishing the final background investigations before bringing the candidates in for a Chief's interview. Anticipate having the new person start March 1st.

SS911: Nothing to report this month but I still need to reach out to SouthSound911 to review our run cards to make sure they know where our equipment is housed so we get the proper equipment dispatched to the call. We have been having trouble connecting with SouthSound911, they have created a new VPN "tunnel", but it has not worked, and we have been unable to download our calls to complete our reports.

Fleet Status: We haven't been able to get Engine 76 back to West Pierce for the remaining repairs that need to be completed. Staffing has been short, and we need 2 people to get the engine delivered. A76 will be leaving for Chehalis on Monday. We will be picking up a reserve aid car from Ashford/Elbe Friday, to keep us in service. We anticipate our new Aid 76 will be ready by the second week of March. We will service the Ashford/Elbe rig before returning to District 23.

Good of the Order: We have completed the outside below grade drain cleaning and have notified Pierce County so if needed, they can make a final inspection. We had Ferrell Gas come out to inspect the holding tank last week, we went through too much propane in too short of time. They inspected the lines from the tank to the building to check for leaks, none found but because of the scorch marks up the side of the water tank, by law he had to tag out the water heater. We have been looking at replacement of the water heater, it's 20 years old. We have 2 bids for replacing the furnaces at Station 77. First, is from the current company who has been doing the quarterly servicing and a second from a company out of Redmond. I have called others, but they have classified us as a commercial business and therefore will not bid on the project and 2 of the Companies suggested have not called back. I will continue to follow up before we have a bigger problem and then we can make some decisions on both projects.

MSO Report; Presented by MSO/LT Lanora Rosenberry:

- 1. We have processed 7 new EMT's in the last month. They have all had their skills evaluation
 - 5/7 are clear to operate with WA DOH
 - 1 is awaiting initial EMT initial certification with WA DOH
 - 1 is currently working on remediation for an expired EMT

All have been attending drills and those who are cleared are signed up for shifts.

- 2. We have done some research and have determined that we would like to purchase a Laerdal Airway Management Trainer with our trauma grant.
 - Its on-line price is \$2,281.00. We were able to negotiate the price to \$1,899.95 plus shipping.
 - It allows us to train on all airway management activities, including BVM, OPA, NPA, Supraglottic airways, suction (with vomit) and IT intubation.
 - All parts of the mannequin are replaceable
 - We are looking to upgrade all current EMTs to supraglottic airway certification. Norma is planning to hold classes for that purpose in the Spring.
